- Approval of the minutes of the regular Town Board meeting held on April 25, 2023.
- RESOLUTION NO. 82 Appoint Seasonal Laborer – Cemetery Operations

WHEREAS, there is a need for seasonal laborers for cemetery operations; and

WHEREAS, the Superintendent of Highways has recommended hiring seasonal laborer Danny Ashley.

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Town Board of the Town of Sweden does hereby appoint Danny Ashley for seasonal cemetery operations not to exceed 40 hours per week.

Sec. 2. That this appointment does not constitute an offer of permanent employment or any benefits that are normally attached to permanent appointments.

Sec. 3. That the rate of pay for will be \$15.00 per hour.

Sec. 4. That the term of appointment will begin on or after May 10, 2023, and end on or before October 20, 2023.

Sec. 5. That this resolution shall take effect immediately.

ADDITIONAL BUSINESS AND ANNOUNCEMENTS:

Tennis/Pickleball/Basketball Court Project – Sweden Clarkson Community Center

Supervisor Johnson asked Recreation Director Jill Wisnowski and Superintendent of Highways Brian Ingraham to be present to discuss the project.

Jill Wisnowski explained that the outdoor basketball courts are falling apart and are not usable. She proposes repairing the current space and creating tennis, pickleball, and one basketball court.
