A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Thursday, December 28, 2023.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Patricia Hayles, Councilperson Randall Hoke, Councilperson Rhonda Humby, and Councilperson Gary Sullivan. Also present were Finance Director Leisa Strabel, Superintendent of Highways Brian Ingraham, Town Attorney Jim Bell, and Town Clerk Karen Sweeting.

Visitors present were Karen LoBracco, Marne Johnson, Maggie Johnson, Reagan Johnson, Kevin Johnson, Grant Johnson, Marcy Johnson, Kevin M. Johnson, Lincoln Tatar, Jackson Robinson, Michelle Trost and Connor Trost.

Supervisor Johnson called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember our first responders and our fighting men and women around the world.

## PRIVILEGE OF THE FLOOR:

Karen LoBracco asked to address specific individuals. Addressing Councilpersons Hoke and Humby – Ms. LoBracco began by thanking them both for their service. It was a different kind of public service that they both responded to and thanked them both for serving out their term once they decided not to run again.

Ms. LoBracco addressed Supervisor Johnson commenting on the several terms he has served and thanked him for encouraging people to come and speak to him, which has made a difference to the feeling in the community adding that we are better for your time spent as Supervisor.

Ms. LoBracco addressed Councilperson Hayles referencing the Sankofa bird – head of the bird faces backwards, think of our ancestors and our history, what went well and what did not; the feet face forward, referencing moving forward; and holds an egg in its beak, signifying new life which is what we hope to see the next few years under new leadership.

### REPORTS OF BOARD AND DEPARTMENTS:

Superintendent of Highways Brian Ingraham reported that things are quiet. They are catching up with equipment and facility maintenance and work orders. He reported an average of salt use for November and a quarter of what is typically used for December.

Town Clerk Karen Sweeting announced they are slowly moving back into the center space at the Town Hall.

Finance Director Leisa Strabel reported that the auditors started their review last week and will continue at the end of January.

Councilperson Hoke shared the building permit report and will make sure the department submits future reports to Councilperson Hayles (newly elected Supervisor as of January 1, 2024) moving forward.

Councilperson Humby met with Recreation Director Jill Wisnowski last week. There has been a lot of turnovers in full-time staff this past year. They have added four more pages of programs to the recreation brochure. Ms. Humby noted how they are thriving and growing.

Councilperson Humby noted the Boxer that was the reason for the presentation at the last meeting has been placed in a home. She also noted the German Shephard that took over a month to capture has now been licensed as a service dog. Mrs. Humby stated that Dog Control is not just about catching dogs, they help rehabilitate and place those dogs. It is a good situation. Councilperson Hoke added, from his capacity in the Sheriff's Department, that Dave Maynard is an amazing public official who takes pride in his work and the Sheriff's Department appreciates his work.

Councilperson Sullivan reported that park activity is slowing down, but many are still coming up and utilizing the facilities – playgrounds and dog park. Buildings and Grounds have been completing several projects at the SCCC.

Councilperson Hayles reported that the CD has been funded from the library. No other news and no report for the Farmers Museum.

Councilperson Hayles wanted to take a moment to recognize the outgoing board members. On behalf of our residents, we want to thank you (Supervisor Johnson, Councilperson Hoke, and Councilperson Humby) these aren't easy jobs, serving the public. We have accomplished a lot in the past few years working together and everybody doing their share of work. It is appreciated. Enjoy your next adventures and congratulations.

Supervisor Johnson reported that the "tri-plex" facility at the SCCC is finished. Mr. Johnson spoke with Buddy Lester because the basketball courts were dedicated to the Lester family. Mr. Lester is on board with the changes and complimented the look and use of the new facility. Mr. Johnson announced that the Town Hall countertops are in and just need some finishing touches before staff can move back into that space.

Discussion: Councilperson Hayles asked if there was any increase in costs for the dog control vehicle and kennel services (Resolutions No. 159 & 160). Supervisor Johnson answered no increases.

Councilperson Hayles, referring to Resolution No.164, the temporary plowing agreement with Villas at Brandon Woods, asked Superintendent of Highways Brian Ingraham to explain the resolution. Mr. Ingraham explained that Wood Trace has been expanded to Phase II of the Villas extending to another road called Natoma Terrace. Highway plow trucks were able to turn around at the end of Wood Trace but can no longer do that due to the extension creating a safety hazard. The agreement allows the Town to utilize that section to safely turn the plows around.
