A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, February 27, 2024.

Town Board Members present were Supervisor Patricia Hayles, Councilperson Scott Maar, Councilperson Tyler Sharpe, Councilperson Adam Staskiewicz, and Councilperson Gary Sullivan. Also present were Finance Director Leisa Strabel, Superintendent of Highways Brian Ingraham, and Town Clerk Karen Sweeting.

Visitors present were Jerry and Marsha Hickey.

Supervisor Hayles called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to honor all those in our armed forces and our first responders and take a moment to reflect on the important work being done tonight.

PRIVILEGE OF THE FLOOR

Resident Jerry Hickey addressed the board regarding parking during the eclipse on April 8, 2024, noting the information posted on the Town's Facebook page. He spoke with Leisa Strabel and was provided with all the background information on the Town's proposal to restrict parking for this event. Mr. Hickey feels the Town should give a welcoming presence to visitors for this event and provide positive options for parking.

Supervisor Hayles appreciates the comments, but the Board needs to look at the event from a public safety point of view. She noted the letter posted on the Town's website and Facebook detailing the need to find a balance for visitors and our residents, preserving our assets. The public hearing is scheduled for March 12, 2024. The Board will take all comments under advisement.

CORRESPONDENCE:

No correspondence noted.

REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Superintendent of Highways Brian Ingraham reported with the lull in the weather they are catching up on some work – drainage work on East Canal Road and Talamora Trail and tree removal from Town properties and cemeteries. They are performing equipment maintenance on snow and ice equipment and spring/summer equipment. Mr. Ingraham reported salt usage for December, January, and to date for February.

Finance Director Leisa Strabel reported that the audit is almost done and will be moving on to the analytics. The report should be available soon.

Councilperson Staskiewicz reported that programs for April 8, 2024 at the SCCC will be cancelled. The only eclipse program will take place prior to April 8th for children to color solar eclipse glasses. The Scoreboard is available. The Easter event is scheduled for March 23rd. Baseball season is starting, and Recreation Director Jill Wisnowski has been working with GLOW for the travel league. In-house baseball is also available. Youth and Senior programs are going well.

Councilperson Sullivan asked if the recreation department is planning any programs promoting the new skate park. Mr. Staskiewicz will find out.

Councilperson Sullivan reported that the kitchen improvements have been completed, minor damage has been repaired at the SCCC and the Town Park. Outdoor facilities have been busy with the mild weather. Mr. Sullivan proposed that the Town take over upkeep of landscaping around the gazebo at the Town Park currently handled by the Sweden Community Foundation.

Councilperson Maar reported that the library has had some issues with the restroom sewer lines backing up. They are looking to renovate the bathrooms with bids going out soon to be completed by June. The sewer line needs to be addressed and may affect the renovation schedule. Supervisor Hayles mentioned that a meeting regarding the sewer line has been scheduled. The interior renovations are funded by the library budget and the outer sewer lines are the responsibility of the municipalities. Mr. Maar met with the new Sweden Library Board representative Ken Streb.

Councilperson Sharpe updated the board on the condition of the mausoleum at Lakeview Cemetery and hopes to at least replace the windows and roof. The Farmers Museum has a "night at the museum" planned for May. The Harvest Festival planning continues. The date has been set - September 14, 2024. They are planning a video recording featuring Don Grentzinger describing the items in the barn.

Supervisor Hayles met with the Village Mayor and Clarkson Supervisor to discuss eclipse planning. A letter has been drafted and will be posted for the public. The Free Rabies Clinic has been scheduled for August 10, 2024. Mrs. Hayles met with representatives to cease the lease with Lifetime Assistance for the sale of 133 State Street. They are discussing details to relocate the nutrition program to the SCCC. Mrs. Hayles attended the Monroe County Supervisors' meeting. Discussion involved eclipse planning. She attended the Sweden Planning Board meeting and conducted interviews for board appointments (ZBA and Environmental Conservation). Mrs. Hayles is scheduled to attend the Town/Gown meeting at SUNY Brockport on Thursday.
