A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, March 12, 2024.

Town Board Members present were Supervisor Patricia Hayles, Councilperson Tyler Sharpe, Councilperson Adam Staskiewicz, and Councilperson Gary Sullivan. Councilperson Scott Maar was absent. Also present were Finance Director Leisa Strabel, Highway Superintendent Brian Ingraham, Town Attorney Jim Bell, and Town Clerk Karen Sweeting.

Visitors present were Joshua Sentiff, Jessica Davis, John and Sandra Cassin, Karen LoBracco, Mike Cunningham, and Jan Preston.

Supervisor Hayles called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence for our first responders, and to remember the families of the Genesee County Sheriff killed in the line of duty over the weekend and the New York State Trooper killed while serving in the National Guard.

PRIVILEGE OF THE FLOOR:

Resident Sandra Cassin addressed the board expressing concerns on the Gary Drive Extension stating that the decision changed their living environment and property. They purchased their property on Gary Drive for the residential atmosphere. They are now concerned with the Town Board's potential decisions regarding parking on Gary Drive during the eclipse event on April 8, 2024. If the parking ban is approved, it would negatively impact family gatherings in that area – limiting the number of guests families can accommodate due to parking. Ms. Cassin suggested allowing parking on one side and utilizing law enforcement by enforcing speed limits and traffic safety instead of towing cars.

Resident John Cassin addressed the board opposing prohibiting parking at the Town Park and Sweden Clarkson Community Center during the eclipse event on April 8, 2024. You are mandating those that want to view the eclipse from the Town Park or SCCC to walk. It will be dangerous to walk along Redman Road or Lake Road to access these locations – forced to walk in the road, no sidewalks. It is unreasonable, unnecessary, and unsafe.

Joshua Sentiff signed up to speak, but said he agreed with the comments offered by Sandra and John Cassin and had no other comments at this time.

CORRESPONDENCE:

Supervisor Hayles received the draft of the Town audit and met with Finance Director Leisa Strabel and the managing partner to discuss the draft. The Town is in good shape, the audit indicates no gaps in our internal controls. The final draft will be forthcoming.

PUBLIC HEARING

At 6:15 p.m. Supervisor Hayles called to order the public hearing. The purpose of the public hearing was to hear all persons regarding the prohibition of parking for one day, April 8, 2024 on the Town Streets and Roads listed on Exhibit A:

Supervisor Hayles waived the reading of the legal notice.

Supervisor Hayles shared the rationale for this proposal. Temporary parking on certain Town roads is being considered for public safety and the ability for emergency vehicles to reach homes if necessary, during the April 8, 2024 eclipse event. It was recommended by public safety officials due to the excessive number of visitors to the area for this event. Mrs. Hayles received updated traffic information at a meeting with the Monroe County Sheriff's Office held on February 6th regarding traffic patterns during the event. It was suggested at that meeting, and encouraged, to adopt temporary parking restrictions. The proposal is for parking restrictions, not closures in high density areas. The Monroe County Sheriff is in favor of any restrictions imposed by municipalities to keep people safe.

Town Attorney Jim Bell detailed Section 170 of the Sweden Town Code pertaining to current parking restrictions and enforcement on Town roads. The Sheriff's Department has the authority to remove cars or issue parking tickets to those in violation of this section.

Supervisor Hayles opened the hearing for comments.

Resident John Cassin addressed the board opposing the temporary parking restriction. Many of the roads listed are in residential neighborhoods and will impact the enjoyment of your residents to view the eclipse with others. Mr. Cassin stated that no other municipality has announced such excessive restrictions. The Sheriff has announced they will focus on major routes, not residential streets. The Town has not demonstrated that Sweden will be affected more than any other Monroe County Town and asks that the Board vote this resolution down.

Resident Joshua Sentiff addressed the board stating that people are coming, you can tell them where to park or not to park. He suggested allowing parking on one side of the street.

Resident Karen LoBracco addressed the board. She stated she lives in the Village, so the streets listed do not apply to her. It would be difficult if parking were allowed on both sides of the street for public safety. This proposal is too much, too late. Many residents have made plans with family and friends, and we should be here to welcome them. Ms. LoBracco suggested prohibiting parking on one side of the street only. Both sides would be an imposition to those that try to follow the rules.

Resident Mike Cunningham addressed the board stating that in the name of safety, he feels it is a good idea, but not enforceable. He asked if fire trucks would be staged around the Town. Supervisor Hayles answered that they will be stationed at their fire stations within the

Town. Mr. Cunningham confirmed that the Brockport Elks Lodge is offering parking during the eclipse event.

No other comments. The Public Hearing was closed at 6:32 p.m.

EXECUTIVE SESSION:

Councilperson Staskiewicz made a motion that was seconded by Councilperson Sharpe to go into executive session at 6:33 p.m. subject to Public Officer's Law Section 108 (3) Confidential Consultation with the Town Attorney. All voted in favor of the motion – four ayes. Motion adopted.

No action taken.

Councilperson Sharpe made a motion that was seconded by Councilperson Sullivan to leave executive session and return to the regular meeting at 7:22 p.m. All voted in favor of the motion – four ayes. Motion adopted.
